## FEATURE OF THE MONTH


Removing the Block Against Principal Contras

#### **OPTIONAL**

By default, BIDS prevents asset managers from trading with brokers acting in a principal capacity however, this block can be removed to increase the amount of liquidity available

#### **POSITIVE RETURNS**

We've observed that asset managers have positive returns when interacting with brokers trading in a principal capacity (see chart below)

\*Trade Size >= 5.000 Shares Returns = Asset manager trading vs. a broker acting in a principal capacity (BIDS ATS 1/1/2020 to 12/30/2022) with a trade size >= 5,000 shares

#### BLOCK SIZE

A users price protection and minimum volume settings will apply – during the period of our study the average execution size on trades >=5k against principal contras was 19,847 shares<sup>+</sup>

#### ANONYMOUS

Because this trading happens via our traditional invite, users can pay any sponsor and the trade is anonymous to the contra both pre and post trade

#### CLEARING

Removing the filter does not change the capacity of a user's order - the sponsoring broker will receive a commission for acting as the asset manager's agent when they trade on the BIDS ATS

#### TO TRY

To remove the filter, contact your BIDS coverage this change can be made in real time and requires no action from the user


